 - Submitted app to Glaser Progress Foundation (20k unrestricted)
 - Denied by Healy Foundation for youth
 - Accepted PPP loan
 - Not sure where we are at with the EID Loan
 - Laurie: There's board concern about taking out another loan
 - Mike: 10k will be forgivable, basically extra PPP loan, having it as a backup in case is good (waiting until Dec. to take it is the greatest outcome)
